


5th MEETING AT PC BHURBAN

MEETING WITH FPCCI




President Anwar Kashif Mumtaz, visited FPCCI headquarter in Karachi along with senior members of his team and discussed the matters of mutual interest regarding tax reforms.

Muhammad Suleman Chawla, Acting President FPCCI has agreed to the various proposals of PTBA including to form a joint committee to promote tax culture in Pakistan, broadening of the tax base, simplification of taxation rates and creating awareness.

President PTBA, outlined his plan of action: (i) chambers & associations should have zero tolerance for the non-filers when it comes, (ii) chambers & associations should not verify or endorse those businesses which are not regular tax filers, (iii) FPCCI & PTBA should jointly organize National Tax Day on 24th February 2024, (iv) there should be valid, up-to-date and reliable national tax database, (v) chambers & associations should promote awareness in the business community to pay their taxes, (vi) FPCCI & PTBA should also collaborate in research and development activities to propose taxation reforms to the federal and provincial governments.

MEETING WITH CHIEF JUSTICE OF PAKISTAN



Meeting with the Chief Justice of Supreme Court of Pakistan with PTBA was a significant opportunity to discuss legal matters and judicial policies.

MEETING WITH CHAIRMAN SECURITIES AND EXCHANGE COMMISSION OF PAKISTAN (SECP) ON ZOOM

In this meeting President apprised the chairman that our members who are dealing with the SECP across Pakistan are facing challenges which in our opinion are creating hardship for new startups and investors, who are coming to Pakistan with the impression that the SECP is equally vibrant and responsive. However, they are facing challenges which include but not limited to timelines, penalties and technical glitches on the SECP web portal.

Following issues were discussed in that meeting:

- 1) Obtaining digital certificate for the company and their hefty fee
- 2) Availability of SECP web portal
- 3) Updation of SECP guidelines and circular on the web portal
- 4) Hefty penalties on non-compliances
- 5) De-centralization of winding up process
- 6) Simplification of rules and procedures in order to promote corporatization and foreign investment.

MEETING WITH STATE BANK OF PAKISTAN

In this meeting following issues were discussed:

- 1. Facilitations to foreign and local investors
- 2. Smooth processes for transmission of dividend, repatriation of profit and payment of interest
- 3. Visibility to trace the application to get exact reason of non-approval

PRESS CONFERENCES

KARACHI NO TAX NO VOTE



In this press conference PTBA has demanded the Election Commission of Pakistan (ECP) to prevent tax non-compliant electoral aspirants from voting for public office.

Addressing the media at the PTBA office on Monday, President Anwar Kashif Mamtaz asserted that tax non-compliant electoral aspirants should preclude contesting polls.

Flanked by PTBA office-bearers including its General Secretary Mohammad Rehan Siddiqui, Senior Vice President Mr. Muhammad Zubair, Treasurer Syed Waseem Hashmi and Imran Ahmed Khan. President demanded that the ECP of Pakistan should reject nomination papers of candidates evading taxes by non filing of returns.

The PTBA President implored the government to facilitate taxpayers, eliminate tax evasion, and bridge the gap between taxpayers and non-taxpayers. He stressed the provision of comprehensive facilities for tax filers and urged the FBR to focus on converting non-filers into contributors. President also insisted on fostering trust in the Pakistan Tax system, deeming it crucial for the success of their initiatives.

He criticized the FBR's practice of issuing tax notices to filers, denouncing the inefficacy of previous attempts and called for connecting tax collection with tangible results. He also decried the adverse repercussions of FBR raids and also highlighted the lack of clarity regarding the amount of taxes collected.

To combat smuggling, president called for a zero-tolerance policy, urging the government and law enforcement agencies to impose comprehensive restrictions on the sale of smuggled goods in the market.
