We are writing this letter in state of anxiety and discomfort on the content and the gist of the letter written by Six Honourable Judges of the Islamabad High Court containing serious allegations of intervention in judicial proceedings and personal lives of the Honourable Judges.

We are sure that these judges have written this letter out of stress and mental agony which has dragged them to express their view publically. Although this is not the usual practice from the judges and we are conscious that these types of pressures and interventions have also allegedly taken place in the past. But these six Honourable Judges have come forward to protect the dignity and esteem of this Honourable institution.

We at Pakistan Tax Bar Association highly recommend to your honor to have a proper investigation to determine the actual cause of this unprecedented event and also request that the reason and people behind this entire conspiracy be identified. We also request that for the purposes of judicial independence the outcome of the investigation is made public and strict action is taken against those found involved in any type of interventions to hamper the exercise of judicial functions and dispensation of justice.

We appreciate your immediate action by holding of a full court meeting and have full confidence that your honor will try your level best to address the above concerns and safe our judicial system and its institutions.
